CRISTA Media Official Contest Rules

Any individual who enters, attempts to enter or in any way participates or attempts to participate in any including contests, sweepstakes and giveaways (hereinafter collectively referred to as "Contest") conducted by CRISTA Ministries d/b/a SPIRIT 105.3, PRAISE 106.5, and CRISTA Media (hereinafter also collectively referred to as "CRISTA") agrees to be bound by the terms and conditions provided in these General Contest Rules as well as by Sponsor's interpretations of these General Rules which are final and binding in all matters relating to any Contest. Some Contests will have specific rules developed for them ("Specific Contest Rules"). In the event there is a discrepancy or inconsistency between these General Rules and the Specific Contest Rules, the Specific Contest Rules shall control.

Unless otherwise noted, no purchase is necessary to enter or win a prize. All contests are subject to and governed by applicable federal, state and local laws and regulations. Participation in this Contest is void where prohibited or otherwise restricted by law.

By participating, you agree a) to be bound by these Official Contest Rules; b) as between you and CRISTA, that the decisions of CRISTA are final on all matters relating to the Contest; c) you are not participating on behalf of any employer or third party; d) in the event that you do not comply with these Rules, if you do not sign and agree to all relevant terms and conditions of the contest, or are otherwise deemed ineligible, that you will be disqualified and your prize (if any) will be forfeited; and e) (when applicable), the potential winner and/or finalist must be available to participate in any portion of the Contest in which participation may be required to be considered eligible.

- b. For PRAISE 106.5: To participate, listeners may email entry to comments@praise1065.com, call the studio hotline as published on air, text a valid keyword to 866-729-1065, or mail entry to PRAISE 106.5 Attn: Promotions Department, PRAISE 106.5, 2211 Rimland Dr., Bellingham, WA 98226. PRAISE 106.5 may require listeners to join THE PRAISE FAMILY on the station website, www.praise1065.com, in order to participate in certain contests. Entry instructions are posted on station website.
- c. Station is not responsible for entries not received or delayed due to delay or error of mail service, internet service outage, computer difficulty, or other technical issues.
- d. For text entry, carrier message and data rates may apply. Text entries are subject to our privacy policy located at https://www.spirit1053.com/privacy or https://www.praise1065.com/privacy. For assistance with an entry for SPIRIT 105.3, text HELP to 89419. For assistance with an entry for PRAISE 106.5, text HELP to 866-729-1065. For a free alternate method of entry, please use one of the other valid entry methods.

2. Eligibility Restrictions:

- a. CRISTA Media contests are open to SPIRIT 105.3 listeners who are 18 years of age or older and who legally reside in the State of Washington and PRAISE 106.5 listeners who are 18 years of age or older, and who legally reside in the State of Washington or in British Columbia, Canada.
- b. Limit to one entry per person.
- c. Only one winner per household is allowed.
- d. Persons who are ineligible to win prizes or participate in contests include: (a) CRISTA employees and their parents, spouses, children, siblings and roommates, (b) employees of advertising agencies that conduct business with CRISTA Media; (c) employees of participating sponsors and promotional partners, and (d) persons employed by radio stations within the Seattle metropolitan area.
- e. For contests with prizes of material goods: contest participants are eligible to win only one material goods contest every 30 days (1 month). If a listener participates in and wins more than one material goods contest in a 30-day (1 month) period, they agree to forfeit any prize beyond the first contest won.
- f. For contests with cash prizes (i.e. Secret Sound): contest participants are eligible to win only one cash prize contest every 5 (five) years. If a listener participates in and wins more than one cash prize contest in a 5-year (five-year) period, they agree to forfeit any prize beyond the first contest won.

By participating in a contest(s), Contest participants agree that SPIRIT 105.3, PRAISE 106.5, CRISTA Media, and contest sponsors have the right to use the participant's name, voice, likeness or any derivative thereof of contest participants and winners for promotional and advertising purposes without compensation.

- 4. CRISTA Media will not disclose or sell participant personal information to parties that are not affiliated with SPIRIT 105.3, PRAISE 106.5 and/or CRISTA Ministries.
- 5. No purchase is necessary. Purchase does not increase odds of winning.
- 6. If Contest-Specific rules are published, in the case of a discrepancy between those rules and the Official Contest Rules, the terms of the Contest-Specific rules will supersede.
- 7. Prizes must be claimed within thirty (30) days of winning date.
- 8. The value of contest prizes will vary from contest to contest. Prizes cannot be redeemed for cash or other merchandise. Prizes are not transferable without approval from CRISTA Media

- 11. CRISTA MEDIA reserves the right to require contest winners to sign a release agreement prior to acceptance and receiving of any prize awarded by station.

By participating, each contest participant waives and releases any and all claims of liability against SPIRIT 105.3, PRAISE 106.5, CRISTA Media, and CRISTA Ministries, its officers, directors, employees, agents, and contest sponsors for any real or threatened damage or personal injury or loss which may occur from participation in the contest or from the use of prizes awarded by CRISTA Media.
- 13. Contestants are required to provide truthful information. CRISTA Media will reject any entry that the station discovers to be false.
