KCIS 630 Official Contest Rules

1. How to Enter Contest:
 - a. To participate, listeners can email entry to comments@kcisradio.com, text a valid keyword to 89419, or mail entry to KCIS 630, Attn: Promotions Department, 19303 Fremont Avenue N., Seattle, WA 98133.
 - b. KCIS 630 may require listeners to join THE KCIS FAMILY on the station website, www.kcisradio.com, in order to participate in certain contests. Entry instruction is posted on station website.
 - c. Station is not responsible for entries not received due to delay of mail service, internet service outage, computer difficulty, or other technical issues.
 - d. For text entry, message and data rates may apply. Text entries are subject to our privacy policy located at <https://www.kcisradio.com/privacy>. For assistance, text HELP to 89419. For a free alternate method of entry, please use one of the other valid entry methods.
2. Eligibility Restrictions:
 - a. Contests are open to KCIS 630 listeners who are 18 years of age or older and who legally reside in the State of Washington.
 - b. Limit to one entry per person.
 - c. Only one winner per household is allowed.
 - d. Persons who are ineligible to win prizes or participate in contests include: (a) CRISTA employees and their parents, spouses, children, siblings, and roommates, (b) employees of advertising agencies that conduct business with CRISTA Media, (c) employees of participating sponsors and promotional partners, and (d) persons employed by radio stations within the Seattle metropolitan area.
 - e. For contests with prizes of material goods: contest participants are eligible to win only one material goods contest every 30 days (1 month). If a listener participates in and wins more than one material goods contest in a 30-day period, they agree to forfeit any prize beyond the first contest won.
 - f. For contests with cash prizes (i.e. Secret Sound): contest participants are eligible to win only one cash prize contest every 180 days (6 months). If a listener participates in and wins more than one cash prize contest in a 180-day period, they agree to forfeit any prize beyond the first contest won.
3. Contest participants agree that KCIS 630, CRISTA Media, and contest sponsors have the right to use the name, voice, or likeness of contest participants and winners for promotional and advertising purposes without compensation.
4. KCIS 630 will not disclose or sell participant personal information to parties that are not affiliated with KCIS 630 and/or CRISTA Media.
5. No purchase is necessary. Purchase does not increase odds of winning.
6. Chance of winning depends on the number of correct and eligible contest participants and entries.
7. Prize amounts and value will vary from contest to contest. Prizes cannot be redeemed for cash or other merchandise. Prizes are not transferable without approval from KCIS 630.
8. Prizes will be mailed to contest winners unless otherwise decided upon by KCIS 630. Station is not responsible for loss or damage of prize when mailed.
9. Winners are responsible for federal, state, and local taxes and fees if applicable. Any person winning over \$600 in cumulative prizes within a calendar year will receive an IRS form 1099 and a copy of such form will be filed with the IRS.
