residents continue to report that they are afraid to leave their suites during the night. complex needs that have accosted other long time residents; yelling and screaming are common situations in the halls; Because of this, many unwelcoming and potentially unsafe environment for the 55 plus residents and residents with disabilities; There have some residents with permanent residents; Drugs and alcohol consumption by residents with complex needs has been occurring in the open. It has created an cohabitation with seniors; There are issues with non-residents being let into the building, creating potentially unsafe environments for Residents with complex needs have been moved in since the declassification without the necessary supports to facilitate harmonious

On top of these concerns, cleanliness of the facility has also become a grave concern. You will remember that on December 24th, 2023, I emailed the Ministry of Social Services about the cleanliness situation of the main level washer-dryer room. At the time, the floor was covered continues to be a concern of residents. in dirt, and feces were smeared on the floor and washer dryer units. While this incident was cleaned, cleanliness in all aspects of the building

often under-resourced and set up to fail. drastic cuts to maintenance under your government. These cuts have meant that local housing authority personnel and front line staff are infestations. Suites are in constant state of pest control due to the cleanliness issues facing the building. Ms. Conway has highlighted the in regards to the efficacy of the on site custodian. A lack of general cleanliness is only made worse by the building's cockroach and bed bugs with the previous owners belongings and weeks have gone by before the suites are properly vacated and cleaned. Concerns have been raised Hallways, common spaces, and suites that become vacant are in desperate need of cleaning and updating. In some cases, suites are left vacant

provide updates where applicable; that the Ministry takes every effort to rid the building of the cockroach and bedbug infestation - no one King Edward for residents 55 years of age or older, or living with disabilities; that the Ministry takes every effort to clean the facility, and The situation is dire at King Edward Place, and so I kindly ask the following: that the Minister join me on a tour of King Edward before the 2024 Provincial Election and meet with residents so they can express their concerns first hand; that the Ministry of Social Services re-classify should have to live with cockroaches and bedbugs as constants in their lives
