AFFIDAVIT

Kurt Bendoraitis, Special Agent, being duly sworn on oath states as follows:

- 1. I am a Special Agent with the Federal Bureau of Investigation and have been since May 14, 2017. As part of my duties, I investigate violations of federal law, including the online exploitation of children, particularly in relation of violations of Title 18, United States Code, Sections 1591, 2251(a), 2252A, and 2422(b) which criminalize, among other things, the production, advertisement, possession, receipt, transportation of child pornography, individuals attempting to persuade, induce, and entice minors to engage in sexual activity, and underage prostitution. I have gained experience in the conduct of such investigations through training in classes and work related to conducting these types of investigations. Specifically, I have received training in the Online Sexual Exploitation of Children. I have been involved in multiple search warrants, arrests, and have conducted online chatting investigations in an undercover capacity. As a federal agent, I am authorized to investigate and assist in the prosecution of violations of laws of the United States, and to execute search warrants and arrest warrants issued by federal courts.
- 2. This Affidavit is made in support of a criminal complaint to arrest **Dana Curtin**, a 48-year-old, white male, born in November of 1973, for violations of federal law involving minors, specifically, Title 18, United States Code, Section 1591 (sex trafficking of a minor).

STATUTORY AUTHORITY

3. This investigation concerns alleged violations of 18 U.S.C. § 1591 involving sex trafficking of minors. That statute makes it unlawful for anyone who knowingly in or affecting interstate or foreign commerce, recruits, entices, harbors, transports, provides, obtains, advertises, maintains, patronizes or solicits by any means, a person or benefits, financially or by receiving anything of value, from the participation in a venture, knowing or in reckless disregard of the fact that the person had not attained the age of 18 and will be caused to engage in a commercial sex act, and attempts and conspires to do the same.

INVESTIGATION

4. On March 9, 2022, an FBI Online Covert Employee (OCE) posted an advertisement on the website "skipthegames.com" to identify individuals attempting to sexually exploit minors online. In your Affiant's training and experience, "skipthegames.com" is mainly used for prostitution. Generally, users will post their advertisements, selling sexual encounters for monetary gain. OCE's advertisement was titled "Tabu Fun" and stated "If your looking for some taboo no limits fun, here's your girl. 200 - hr, 150 - hhr, 125 - qv". The final portion of the title used language commonly found on skipthegames.com and other online sites to refer to prices, meaning \$200 for an hour, \$150 for a half hour, an \$125 for a quick visit. The post included two photographs of an FBI confidential human source (CHS) with the face of the CHS blocked out in the advertisement. The post also included a phone number to contact OCE.

5. Also on March 9, 2022, a user with telephone number 309-369-5758 (Subject), sent a text message to OCE in response to the advertisement. The text message conversation continued through May 19, 2022. In it, the Subject discussed paying \$150 for a half hour with a 12-year-old girl and arranged to meet. The following is an excerpt of the conversation:

Subject: Available tomorrow early afternoon

OCE: Yep How long u want

Conversation continues on March 10, 2022:

Subject: If you're available for incall a hhr would be great

OCE: What time? What u looking to do

Subject: 2:00ish

Subject: Looking to do?

OCE: Like she doesn't do anal just making sure u know

Subject: Who is this?

Subject: Thought I was talking to her?

OCE: I'm her dad. I posted the ad for her

Subject: the age in the ad says 99?

OCE: Well shes a lot younger than that

Subject: What part of town is incall?

OCE: Near the old mall

Subject: Ok thanks

Subject: Am I meeting both of you?

OCE: No need to meet me

OCE: Make it 3? Gotta pick her up from middle school and doesn't get put until 245

Subject: Oh ok. Thought it was spring break.

OCE: No that's not till closer to easter

Subject: 3:00 tomorrow sous great. Where will I be headed?

OCE: I can get a hotel room unless u got one already

Conversation continues on March 29, 2022:

Subject: You have a hotel room?

Subject: ???

Subject: Hello

Subject: Damn

OCE: Hey couldn't get a room for a decent rate today

OCE: No one else lined up today so a hotels not rly worth the 200 if u wanted akh r

OCE: An**

Conversation continues on March 31, 2022:

Subject: Feel free to lmk when you have an incall set up and I'll come.

Conversation continues on April 27, 2022:

OCE: Hey u still want this lil [cat emoji]

Subject: Sure

OCE: How long u want

Subject: What are my options?

OCE: 200 hr 175 hhr 125 qv

Subject: What's qv

OCE: Quick visit, like blow job

Subject: So different prices gets extra services

OCE: what u wanting?

Subject: I have 150

OCE: U can get a hhr

OCE: She doesn't do anal

Subject: When and where.

OCE: Could do tomorrow after I pick her up from middle school

Subject: Oh I thought you meant today. Can't tomorrow.

OCE: Ohhhh lemme see if I could move something's around

OCE: What time would work for ya

Subject: 3:00ish. Incall?

OCE: That could work

OCE: U ever been with a 12yo before? I'm onl asking to make sure u don't go tip to balls

deep in the first pump cuz my only rule is no pain

OCE: I'll know for sure in bout 20 mins. Not sure if I could get out of work early today

OCE: I'm sorry I cant get off that early

Subject: Ok thanks

OCE: Hmu tomorrow or later

Conversation continues on May 13, 2022:

Subject: How's everything

Conversation continues on May 18, 2022:

OCE: Good

OCE: Hru

Subject: Love to get together

Conversation continues on May 19, 2022:

OCE: Yea!

OCE: We could be good today

Subject: Ok lmk the plan.

OCE: How long u want this sweet 12yo pussy

Subject: I'm not sure what 12yo means and don't wanna know but I think 150 half was what we talked about last time

OCE: Umm shes 12 remember. And yes 150 works for half. U got condoms?

Subject: Sure.

Subject: I honestly can't remember the ad it's been so long ago. Don't remember looks or anything.

OCE: [photograph of an FBI Confidential Human Source (CHS) utilizing a filter to appear younger sitting at a table eating something out of a bowl]

Subject: Ok. Just lmk the plan

OCE: Does 4 work for u

Subject: I can tell you a little closer to 4. But it should. 4:30 at the latest.

OCE: That works

OCE: Lmk u close to the heights

Subject: Yeah. Not too far

OCE: Just send me a pic of the cash for verification. Been fucked over before

Subject: [image of 150 dollars cash (7 20-dollar bills and one 10-dollar bill) with a hand holding the cash]

OCE: Ur good

Subject: Where will we be meeting

OCE: Near the heights. And she doesn't do anal

OCE: Nvm let's go by the old mall at the residence

Subject: We can do near the heights

OCE: Ok. Sounds good

OCE: Hey let's meet at the star bucks in the heights

OCE: The one by emos

Subject: Then what

OCE: either go back to my place unless u got a spot by here or does ur car have tinted

windows

Subject: Your place is good. Want me to just come there?

OCE: Tbh I'd rather make sure ur legit b4 u get my address

OCE: We live like 2 mins from there and could walk if it wasn't so fucken hot haha

OCE: She was asking if u were looking for a bj or just sex

Subject: Both? Thought we just have a half hour to play.

OCE: Yeah u do. She just asking me so I wanted to let her know

OCE: Dude way? If u don't want this lil [cat emoji], it's cool but lemme know so were not

waiting around all day

Subject: 20 minutes

OCE: [thumbs up emoji]

Subject: You there

OCE: No are u there?

OCE: Be there in 2

Subject: Ok

OCE: Can u get her a dragon fruit smoothie from starbuck? I'll take off 25 from the price

OCE: Almost there

6. Agents conducted open source and law enforcement database checks for

telephone number 309-369-5758. The checks revealed the telephone number was used by

Dana Curtin from Metamora, IL. Agents then conducted checks for Dana Curtin from

Metamora, IL and a photographic identification was obtained from the Illinois Secretary

of State along with a possible vehicle, a red 2014 Dodge Ram 1500 with Illinois license

plate 1489675B.

7. On May 19, 2022, at approximately 4:15PM, FBI Special Agents and Task

Force Officer set up surveillance at the Starbucks located at 3706 N Prospect Road, Peoria,

IL. At approximately 5:13PM, surveillance observed a Red Dodge Ram 1500 with Illinois

license plate 1489675B pull into the Starbucks parking lot. This was approximately the

same time OCE received the message "You there". Then, FBI Special Agents converged

on the vehicle and placed the driver under arrest. The driver was identified as Dana

Curtin. A mobile phone was seen in the vehicle near the driver's seat. OCE called the

Subject's telephone number and the phone in the vehicle began to ring.

8. Curtin was then brought to an FBI issued vehicle to be interviewed. Curtin

was provided his Miranda Warnings via an FBI Advice of Rights form. Curtin agreed to

speak with Agents and provided the following information: Curtin was talking with a

guy after responding to an advertisement on "skipthegames". The guy told Curtin the advertisement was for his daughter. Curtin stated the daughter was 12 years old and in middle school. Curtin stated he was at Starbucks to see if the daughter was real and was then going to tell someone. Curtin stated he was not going to have sex with the 12-year-old. Curtin stated he had approximately 290 dollars in his wallet and had condoms in his car. The condoms had been in his center console for approximately a month. Curtin stated his wife did not know about the condoms in his vehicle. Curtin had paid for sex with prostitutes from "skipthegames" over 10 separate times. Curtin did not tell anyone he was going to Starbucks and did not call the police. Curtin stated sex was implied while using "skipthegames" because it was in the advertisements. Curtin consented to allow Agents to search his vehicle.

9. Special Agents and TFO then searched Curtin's vehicle. Found in the center console were two condoms. Also found in the vehicle was Curtin's wallet. There was 240 dollars in cash and 150 dollars of the total cash was separated from the other cash inside the wallet.
