VIP CABIN RENTAL

The VIP cabin is actually a comfortable park model camper that can accommodate 4 guests. It has one queen size bed in the main bedroom, and full size bunk beds in a second bedroom. It has TV and DVD player, and heating and air-conditioning. Furniture includes reclining chair, couch, table and chairs. Both cabins have a fire pit, kitchen with stove, sink, refrigerator, dinnerware, silverware cookware, toaster, coffee maker, microwave, kitchen linens and cooking utensils. They also have a bathroom with shower, lavatory and commode and some linens provided. You may want to bring extra linens if you're staying longer than a few days.

Cabins include two vehicle passes. Additional vehicles and guests are subject to normal gate fees. Normal boating and golf cart fees also apply. There is a two night minimum for reservations. No pets allowed in VIP. Check IN is 2:00pm or after. Check OUT is 12:00 noon for all rental units. No smoking in any rentals.

Note: Due to the nature of our programs that are heard on-line, contests heard on the radio station's Internet audio stream are slightly delayed from the time the contests heard on the broadcast station and may be running behind the broadcast signal.
