-Listeners may enter each new keyword on the JACK's Big Adventure landing page at 963jackfm.com once per timeslot each day for valid entry.

Note: due to the nature of our programs that are heard on-line over the Internet, contests heard on the radio station's Internet audio stream are slightly delayed from the time the contests heard on the broadcast station and may be running behind the broadcast signal.
