### **HOW TO ENTER – ADDENDUM A**

- Weekdays beginning Monday, May 6 through Friday, May 10, 2024 at approx. 5:40pm CST, listeners will be prompted with a "cue to call" on-air to answer a question correctly for a chance to win a pair of GA tickets to the Stevie Nicks concert on May 14, 2024 at Bridgestone Arena and will qualify for an upgrade into the EuroStone Suite for the show.

- A Grand Prize winner will be randomly selected from all qualifiers. - All qualifiers must be eligible and in no conflict of the station's contest rules. - The Grand Prize winner must be over the age of 21. - MWC will issue 1099 to the Grand Prize winner.

Note: due to the nature of our programs that are heard on-line over the Internet, contests heard on the radio station's Internet audio stream are slightly delayed from the time the contests heard on the broadcast station and may be running behind the broadcast signal. Thus, all contests heard are delayed. This delay can last for 30 seconds up to several minutes. This means that when the station announces winning names in this contest, listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contest on conventional radio.

For this contest, the station will start counting down when the announcement is made on the radio broadcast signal.
