Text the keyword to 865-656-2975 within 15 minutes of the announcement. Two qualifiers will be randomly selected from each entry period.
- 2. Last Chance Qualifier Event: Attend a B97.5 remote broadcast at a Knoxville Wholesale Furniture location (location to be announced) during the week of June 23, 2025, for a chance to receive a "Fast Pass" to the grand prize event. You must be present during the live broadcast to qualify. Dates, times, and location details will be posted at www.B975.com.
