### **ADDENDUM B - METHOD OF SELECTION OF WINNER**

#2: Caller nine will get to hear a one second "snippet" of a song that is played. Caller must name full and correct artist name and the name of the song. That "snippet" may stay in play until it is correctly guessed.

#3: Please note that the first guess is the final guess.

#4: If caller names the correct artist and song title, they will win \$1000.00.

#5: The one second clip of the song will remain the same until someone guesses correctly. After the correct song is guessed, a new song will be used starting the following play.

#6: Please note that if the caller is driving a vehicle it must be pulled over and in a safe area.

KTCO is not responsible for any technical errors that may happen during the contest, including (but not limited to): lost cell-phone coverage or disconnection of call by any means.

Due to the nature of our programs that are heard on-line over the Internet, contests heard on the radio station's Internet audio stream are slightly delayed from the time the contests heard on the broadcast station, and will be running behind the broadcast signal. Thus, all contests heard are delayed. This delay can last for 30 seconds up to several minutes. This means that listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contest on a conventional FM radio.
