NOTE: *Due to the nature of our programs that are heard on-line, contests heard on the radio station's Internet audio stream are slightly delayed from the time the contests heard on the broadcast station and may be running behind the broadcast signal. Thus, all contests heard are delayed. This delay can last for 30 seconds up to several minutes. This means that when the station announces winning names in this contest, listeners to the on-line audio stream may be at a disadvantage in participating over those listeners who hear the contest on conventional radio. For this contest, the station will start counting down when the announcement is made on the radio broadcast signal.*

ADDITIONAL CONTEST NOTES

HOW TO ENTER:

1. Participants will be randomly selected from all eligible entries after fully completing the registration process on the "Jay Mac & Drake Classic Rock on the Clock" page at wimz.com.
2. Selected contestants will be contacted prior to participation using the contact information provided at the time of entry.
3. If a selected contestant does not answer after a second call attempt, they will forfeit their opportunity to play that day. However, their name will be returned to the pool of eligible entries for a future random drawing.
4. The contest will be prerecorded and broadcast at a later date and/or time.
5. If WIMZ is unable to reach the preselected contestant before the scheduled recording time, an alternate contestant will be randomly selected from all eligible entries.
6. If a contestant is unavailable on their scheduled play date, they must notify the WIMZ business office at (865) 525-6000 during normal business hours at least one (1) business day prior to their scheduled appearance. Failure to provide timely notice will result in their name being returned to the general entry pool for a potential future opportunity.
7. If a contestant notifies the station at least one (1) business day in advance that they are unable to participate, they will be rescheduled for a future date and notified at least one (1) day prior to their new scheduled play time.
8. Contestants may participate no more than once within any 30-day period.
9. The selected contestant must personally provide the song title and artist during the call. Proxy participants are NOT permitted.
10. If all previously selected contestants are unavailable on a given date, WIMZ may invite a caller from (865) 656-ROCK or (865) 656-ROLL to participate. The caller must not have played within the previous 30 days.

NOTES ON GAME PLAY:

1. Once the contest begins, the contestant will have thirty (30) seconds to correctly identify seven (7) song clips by both song title and artist, as played by the on-air hosts. If the contestant correctly identifies all seven (7) song clips within the allotted 30 seconds, they will win \$1,000.
2. Contestants may "pass" on a song clip; however, any passed clip must be answered before time expires. Any clip left unanswered when time runs out will automatically be marked incorrect.
3. If time permits, contestants may revisit and attempt to correct previously missed answers before the clock expires.
4. All answers judged incorrect at the end of the 30-second period are final and not subject to appeal or dispute.
5. Contestants who do not correctly identify all seven (7) song clips within the allotted time may be eligible to receive a participation prize from WIMZ or a WIMZ affiliate. Participation prizes are not guaranteed, are subject to availability, and must be redeemed within thirty (30) days of participation.
6. WIMZ is not responsible for technical difficulties that may occur during the contest, including but not limited to: dropped calls, loss of cell-phone coverage, poor reception, service interruptions, or any other issue that prevents completion of gameplay.
7. In the event of a technical disruption, the contestant will not be permitted to resume play that day but will be returned to the drawing pool for a future opportunity to participate.
