## MARK AND DILLY'S WISH LIST Official Contest Rules & Regulations (the "Rules")

- The Mark and Dilly's Wish List contest (the "Contest") is brought to you by CFJL-FM HOT 100.5 (the "Station"), of Dufferin Communications Inc. (the "Contest Organizer"). The Contest starts on September 3, 2024 between approximately 8:00 a.m. -8:59 a.m. CDT and closes on October 15, 2024 between approximately 12:00 p.m. -12:59 p.m. CDT (the "Contest Period"). No purchase necessary. Void where prohibited.
- 2. ELIGIBILITY. This Contest is open to individuals who are a legal resident of Manitoba, Canada and are eighteen (18) years of age or older at the start of the Contest Period. Employees and their parents, siblings and children, and individuals domiciled with an employee of the Contest Organizer, its agents, parent, affiliated or related companies, subsidiaries, divisions, prize sponsors, and promotional and advertising agencies and administrators, are ineligible to enter. A winner of a Station contest within the sixty (60) days preceding the start of the Contest Period (including any individuals designated by such winners to take ownership of prizes) and individuals domiciled with such a winner are ineligible to enter and may be disqualified.
- 3. TO ENTER. From September 3, 2024 between approximately 8:00 a.m. -8:59 a.m. CDT until approximately 11:00 a.m. CDT on October 15, 2024, individuals can sign-up for the Contest on HOT 100.5 FM at https://hot1005fm.com/mark-dillys-wishlist/ (the "Participant(s)") and also view Mark and Dilly's Wish List ("Wish List") containing one-hundred (100) wishes. The Official Wish List with descriptions of the Wish List wishes and their approximate retail values is included at Appendix "A" below. During the Contest Period a Participant's name will be randomly drawn from the pool of eligible Participants, four (4) times per weekday (Monday- Friday, except September 30, 2024 and October 14, 2024). An on-air cue-to-text announcement of the names drawn that day will be aired on the Station, one name each, between the possible times of: 7:00 a.m.-7:59 a.m. CDT; 8:00 a.m.-8:59 a.m. CDT; 12:00 p.m.-12:59 p.m. CDT; and 4:00 p.m. - 4:59 p.m. CDT (except October 15, 2024) (each, an "Announcement"). If a Participant whose name is announced sends a text message to the Station's contest line (204-474-1005), and then answers the Contest Organizer's telephone call and provides the wish they want eliminated (which must be a wish not already eliminated) from the Wish List, all within sixty (60) minutes from the time that their name is announced, the Participant will be declared a qualifier (a "Qualifier") for the Prize Draw (defined below). The Qualifier may be announced on-air and may be required to chat on-air. Once a Qualifier eliminates a wish from the Wish List, that wish is no longer available to be won as a prize in the Prize Draw. The Qualifier will be required to provide a representative of the Contest Organizer with their name, address, telephone number, and such other information as may be required to administer the Contest.
- 4. - 5. Those listening via the on-demand player online or via a mobile app may experience a delay of five (5) minutes or more than that of the terrestrial radio feed.
- 6. If there is not a clear telephone connection between the Station's on-air announcer and a caller, such that one or each other cannot hear the other, such caller will be disqualified, and the Contest

Organizer will not be liable in any way for such failed connection. In conducting the Contest, the Contest Organizer and its representatives have the full and absolute discretion to disqualify any caller whose response cannot be heard by the Contest Organizer's representative, and the Contest Organizer shall have no liability or responsibility to any caller so disqualified.

- 7. Contest entrants shall be responsible for any long-distance charges, text message fees, or other fees charged by their service provider in connection with entering the Contest.
- 8. Unless otherwise specified, entrants must have a valid e-mail address in order to participate in the Contest. Entrants must provide an entry that fulfills the Contest requirement, as specified on the Station website, to be eligible to win. Entries that do not include all of the required information and adhere to the Contest rules will be considered void. The Contest Organizer has sole discretion to determine if an entry meets the Contest requirements and otherwise complies with the Contest rules.
- 9. Limit one (1) entry per individual. If it is discovered that an individual has attempted to enter more than once, whether using falsified information, fraudulent conduct, or other means, all of the individual's entries will be void and a police report will be filed documenting the conduct.
- 10. **PRIZE DRAW.** On October 15, 2024, at approximately 1:00 p.m. CDT, a potential winner (the "**Potential Winner**") will be randomly drawn from the eligible Qualifiers at 202-1440 Jack Blick Avenue, Winnipeg, Manitoba (the "**Prize Draw**").
- 11. **POTENTIAL WINNER CONTACT.** On October 16, 2024, between 8:00 a.m. 8:59 a.m. CDT, the Contest Organizer, acting reasonably, will attempt to contact the Potential Winner to notify them that they may have won the Prize by telephone. In the event that the Potential Winner cannot be contacted immediately they may be disqualified and an alternate potential winner may be drawn at the Contest Organizer's sole discretion. The Potential Winner may be announced on-air and may be required to chat on-air. The Potential Winner will then be required to provide a representative of the Contest Organizer with their name, address, telephone number, and such other information as may be required to administer the Contest.
- 12. If there is not a clear telephone connection between the Station's on-air announcer and the Potential Winner, such that one or each other cannot hear the other, such Potential Winner will be disqualified, and the Contest Organizer will not be liable in any way for such failed connection. In conducting the Contest, the Contest Organizer and its representatives have the full and absolute discretion to disqualify any Potential Winner whose response cannot be heard by the Contest Organizer's representative, and the Contest Organizer shall have no liability or responsibility to any individual so disqualified.
- 13. The provisions and procedures referred to above relating to the selection and notification of a potential winner shall be applied, with the necessary amendments, until a qualified winner has been duly selected, but in any event, by no later than December 10, 2024.
- 14. **PRIZE.** There is **one (1)** prize available to be won, such prize being the sole remaining wish not eliminated during the Contest Period (the "**Prize**"). **The Official Wish List with descriptions of the**

Wish List wishes and their approximate values is included at Appendix "A" below. The range of approximate retail values of the wishes is between \$4,205.58 to 5,298.00.

- 15. If the Prize is not in the form of a cheque payable in the name of the Prize winner, the Prize winner may instead substitute the Prize for a cheque in the amount of five thousand dollars (\$5,000.00) payable in their name.
- 16. The Prize must be accepted as awarded. The Prize may not be sold or transferred and is not substitutable by the Prize winner or convertible to cash, except as set out at paragraph 15 above where the Prize winner may substitute the Prize for a cheque in the amount of five thousand dollars (\$5,000.00) payable in their name, as applicable. The Contest Organizer reserves the right, in its sole discretion and for any reason: to substitute the Prize in whole or in part in the event that all or any component of the Prize is unavailable, or cannot be provided due to circumstances beyond the control of the Contest Organizer; to substitute and/or modify the Prize or any portion thereof with a Prize of equal of greater value; and/or, substitute the Prize with the monetary equivalent of its applicable approximate retail value. The Prize, or any portion thereof, will not be replaced if lost or stolen.
- 17. The Prize winner is solely responsible for any and all costs not expressly described herein, including, but not limited to, delivery charges, shipping costs, items of a personal nature, souvenirs, taxes, insurance, gratuities, and all personal expenses of any kind or nature. The Contest Organizer is not responsible for any delay, postponement, suspension, rescheduling or cancellation, for any reason, of the Prize, and the Prize winner will not be compensated in the event of such delay, cancellation, or other event described herein.
- 18. If the Prize is a trip, as set out at wishes numbered 21, 22, 76, or 77 on the Official Wish List included at Appendix "A" below, terms and conditions set out at (i) to (xii) also apply:
  - i. To be eligible for travel, the Prize winner must be twenty-one (21) years of age, or older. If the Prize winner is below twenty-one (21) years of age, the Prize winner will instead receive a cheque in the amount of five-thousand dollars (5,000.00) as the Prize instead of the trip.

- ix. If the Prize, or any portion thereof, is unused, it cannot be carried forward and will be forfeit.
- x. The Travellers must comply with all applicable laws, including but not limited to, all local laws while in destination.
- xi. The Travellers acknowledge the risks related to the spread of infectious or contagious disease, and that it remains their responsibility to take the necessary precautions applicable to any health hazards, including but not limited to COVID-19. It is the responsibility of the Travellers to abide by all applicable public health and governmental laws, regulations and directives, including but not limited to as it relates to testing, self-isolation or quarantine. It is also the responsibility of the Travellers to adhere to all applicable mandatory safety protocols, including but not limited to those that have been introduced by the provider of any Prize component.
- xii. The Contest Organizer and the provider of any Prize component have the right, in their absolute discretion, to disqualify and/or remove any Traveller from any activity at any time if such individual is at any point uncooperative, disruptive, abusive, or unobservant of applicable rules, laws or regulations, or if such individual is likely to cause or has caused damage to person, property, or the reputation of the Contest Organizer and/or the provider, as determined in their respective absolute discretion as applicable.
- 19. **PRIZE SUPPLIER.** The prize supplier is Dufferin Communications Inc.

The odds of winning the Prize from among the applicable Qualifiers shall depend on the number of applicable Qualifiers, but will be at least one (1) in ninety-nine (99).
- 21. **AWARDING OF PRIZES.** Proof of identification must be provided upon request. In order to be declared a winner, the Potential Winner must first correctly answer, unaided, a time-limited mathematical skill-testing question administered by the Contest Organizer. The Contest Organizer and/or its suppliers do not assume liability for any loss, damage or injury of any nature in whole or in part resulting from an act of God or any other force majeure condition including without limitation: fire, volcanic eruption, environmental pollution or contamination, inclement weather, earthquake, flood, explosion, water or power shortages or failures, storms or hurricanes, riots or civil commotions or disturbances and any other acts of similar nature, sabotage, arrests, strikes, boycotts, picketing, lockouts or other labour disruptions, inability or failure of a third party service provider to provide services and/or products, restraints of rulers or peoples, expropriations, acts of terrorism, public enemies, war, invasion, insurrection, national emergency, epidemics, pandemics, quarantine restrictions, government health advisories or warnings or alerts of any kind or nature, government seizures, any laws, rules, proclamations, regulations, orders, declarations, advisories, actions, interruptions or requirements of or interference by any government or governmental agency thereof, refusal or cancellation or suspension or delay of any government authority or any license, permit or authorization, damages to its facilities or the supplier and its facilities, any other unforeseen circumstances in any country in the world or any other cause or causes of any similar nature that impacts negatively on or hampers its ability to fulfill any of its contractual conditions (all of the foregoing being herein referred to as an "Event of Force Majeure"). In the event that any of these conditions apply, the Contest Organizer shall be excused, discharged or released from its performance to the extent such performance is so limited or prevented, without liability of any kind and the Contest Organizer's non-performance shall not be deemed a breach of these Contest Rules. In such case, the Prize shall be forfeited.
- 23. The Potential Winner must claim the Prize either within sixty (60) days of being selected as a Potential Winner or at least forty-eight (48) hours before the Prize is to be redeemed or used, whichever occurs first. The Potential Winner is responsible for claiming the Prize from the Station, and is solely responsible for their transportation to and from the Prize pickup location. If a Potential Winner does not claim the Prize within this time period, the Prize will be considered forfeit and the Contest Organizer may, at its sole discretion, select an alternate winner.
