Dear Madam Secretary,

On behalf of the 28 Kentucky state senators who have co-signed this letter, we express our sincere appreciation for your service to the American people. Thank you for your continued leadership and commitment to public safety and national security. We respectfully request that you, along with the appropriate federal agencies, suspend and delay the implementation of the REAL ID requirement currently set to take effect on May 7, 2025.

This federal mandate will require all Kentuckians to possess a REAL ID to board U.S. commercial flights or access military bases and certain federal facilities. While the intent behind REAL ID is understandable, we believe the practical impact on Kentuckians must also be considered.

Despite significant progress, Kentucky is simply not fully prepared for complete implementation. The transition to a regional driver's licensing model has brought improvements. However, it has also resulted in limited appointment availability and long wait times at many regional offices across the state. If the REAL ID requirement moves forward as scheduled, it will further strain already overburdened regional offices and create unnecessary hardship, particularly for seniors, rural residents, and working families who may struggle to access the necessary documents or transportation. Some measures were passed in this last legislative session, but these will not be implemented before May 7.

The REAL ID deadline has been delayed multiple times for similar reasons, and we believe another reasonable extension is warranted to ensure a smoother, more accessible rollout.

We appreciate your time and thoughtful consideration of this urgent matter. We urge you to act in the interest of the people and delay the REAL ID effective date once more.
