1. INTRODUCTION

These Official Rules ("Rules") govern the "Sizzlin' Summer Giveaway" contest ("Contest") conducted by Adams Radio Group of Tallahassee ("Station Group"). This promotion is being simultaneously aired and promoted across the following participating radio stations: HOT 104.9 (WHTF-FM), 103.1 The Wolf (WWOF-FM), Tally 99.9 (WXTY-FM), and Vibe 106.1 (WQTL-FM). These Rules supplement the Station Group's General Contest Rules available at hot1049.com, 1031thewolf.com, tallyradio.com, and vibe1061.com. In the event of any discrepancy between these Rules and the General Rules, these Rules will control.

2. AGREEMENT TO RULES

Participation in the Contest constitutes full and unconditional agreement to and acceptance of these Rules and the General Rules. Decisions of the Station are final and binding in all matters related to this Contest.

3. ELIGIBILITY

The Contest is open to legal U.S. residents of Florida and Georgia within the Station's Total Survey Area who are at least 18 years of age at the time of entry. Employees, agents, officers, directors, and immediate family members of the Station, its parent company, affiliates, and promotional partners are not eligible to participate.

4. HOW TO ENTER

To enter, listen to any participating Adams Radio Group of Tallahassee station — HOT 104.9 (WHTF-FM), 103.1 The Wolf (WWOF-FM), Tally 99.9 (WXTY-FM), or Vibe 106.1 (WQTL-FM) — during designated entry times each weekday from July 1, 2025, to August 29, 2025.

At 9:00 AM, 11:00 AM, 2:00 PM, and 4:00 PM Eastern Time, a keyword will be announced on air. Upon hearing the keyword, listeners must text it to the designated contest number (as announced on-air) within the specified entry window.

Each correct and timely keyword submission will be entered into a pool of qualifiers. Qualifiers will be randomly selected from the valid entries received during each designated entry period across all participating stations.

Message and data rates may apply. Limit one entry per phone number per keyword per entry window.

Failure to listen at the correct times or to submit the correct keyword within the designated entry window will void your entry. Adams Radio Group of Tallahassee and participating stations are not responsible for missed or incorrect entries.

Participating stations are not responsible for technical issues including, but not limited to, delayed or undelivered text messages, carrier outages, or incorrect entries due to auto-correct or user error.

Winners will be notified by phone or text message. Prizes must be picked up in person at 2222 Old St. Augustine Road, Tallahassee, FL 32301, unless otherwise specified. Proper government-issued ID and any required tax documentation (including a W-9 form) must be provided.

Failure to respond within five (5) business days or to complete all required paperwork will result in forfeiture of the prize. Unclaimed prizes may be awarded to alternate entrants or forfeited at the Station's discretion.

7. ODDS OF WINNING

Odds of being selected as a qualifier or winner depend on the number of eligible entries received.

8. TAXES

All federal, state, and local taxes associated with winning are solely the responsibility of the winner. Prizes valued at \$600 or more will require an IRS Form 1099, which will be issued to the winner.

The Station also reserves the right to record, photograph, or otherwise document winners during prize redemption or any on-site promotional event for use in advertising, marketing, or social media without further compensation, unless prohibited by law.

The Station reserves the right to cancel, suspend, or modify the Contest if fraud, technical failures, or any other factor impairs the integrity of the Contest. The Station may disqualify any individual it believes has violated these Rules or acted in a disruptive or unsportsmanlike manner.
