THE GRAND JURY CHARGES that on or about May 1, 2020 in Metcalfe County, Kentucky the defendant committed the crime of UNLAWFUL TRANSACTION WITH A MINOR, 1<sup>ST</sup> DEGREE, ILLEGAL SEX ACT, UNDER 16 YEARS OLD when he knowingly induced, assisted or caused a minor to engage in illegal sexual activity, specifically when he induced, assisted, or caused M.B., a minor less than 16 years old, to engage in sexual contact between them.

THE GRAND JURY CHARGES that on or about May 15, 2020 in Metcalfe County, Kentucky the defendant committed the crime of UNLAWFUL TRANSACTION WITH A MINOR, 1<sup>ST</sup> DEGREE, ILLEGAL SEX ACT, UNDER 16 YEARS OLD when he knowingly induced, assisted or caused a minor to engage in illegal
