CAT COUNTRY NETWORK "MEGAN MORONEYWEEK" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WCTO/WWYY/WSJR/WBHD ("Station"), 2158 Avenue C, Suite 100, Bethlehem, PA 18017, during available business hours Monday through Friday, Station website www.catcountry96.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the Cat Country 96 & 107.1 and Cat Country 93.7 & 95.7 Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Only one (1) entry per person per phone number per giveaway will count as a submission for the duration of the contest period. Multiple daily texts will be accepted but will not increase your odds of winning. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.
- 4. **Winner Selection.** There will be one (1) winner for each giveaway during the contest period. One (1) giveaway each day.
