WCTO/WWYY/WSJR/WBHD "SHANIA TWAIN WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **Cat Country Network** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

Eligibility.
