## 100.7 LEV'S "JONAS BROTHERS WEEKEND" CONTEST OFFICIAL RULES

The Station will conduct the **100.7 LEV's "Jonas Brothers Weekend"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Contest Period. The Contest entry period will begin at 5:00amET on July 18, 2025 and will run through 11:55pm ET on July 20, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

<u>Text</u>: Send a text message with the keyword JONAS spelled correctly to 610-720-1007 during the Contest Period. All entries must be received by 11:55pm ET on July 20, 2025 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

3. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.
