The Station will conduct the Cumulus Media Radio Station Group Allentown Contest Cat Country 96 & 107.1, 100.7 LEV, Lehigh Valley Fox Sports "Merry KIDSmas" Contest and The Hawk's "Santa Stash" Contest (the "Contest") substantially as described in these rules.
