99.9 THE HAWK'S "WHAT THE HAWK" CONTEST OFFICIAL RULES

The Station will conduct the **99.9 The Hawk's "What The Hawk"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:
