## B98.7's "Jonas Brothers" Contest Official Rules

All entries must be received prior to the expiration of 4:59 PM MT on the day the Contest Round in which the Keyword was announced to be eligible to win the prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.

4. **Winner Selection.** On or about 7:00 AM MT on Tuesday November 18, 2025 – Monday November 24, 2025 a potential winner will be chosen in a random drawing from among all valid entries received by Station during the previous day of the Contest Period.
