## 101 THE FOX'S "SPARKS AND LUX CHRISTMAS GIFT MATCH" CONTEST OFFICIAL RULES

The Station will conduct the 101 The Fox's "Sparks and Lux Christmas Gift Match" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, twenty-one (21) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 15 days or a prize valued at \$500 or more in the last 15 days, and whose immediate family members or household members have not won a prize from the Station in the last 15 days or a prize valued at \$500 or more in the last 15 days. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state, and local laws and regulations. The Contest entry period will begin at 6:15am CT on December 1, 2025 and will run weekdays 6:15am CT through 8:30am CT on December 19, 2025 or when the final two (2) squares (presents) are matched, whichever is earlier (the "Contest Period"). The Station's computer is the official time keeping device for this Contest. This contest will not play on December 11, 2025.
- 3. **How to Enter and Win.** Prior to the start of the Contest Period, a "Sparks and Lux Christmas Gift Match" grid will be established, published and downloadable at Station's website, www.101thefox.net. Participants can download and use the grid to aid in their participation and selection of squares (gifts) on the grid throughout the Contest. Listen to the Station during the Contest Period. At or around **6:15am**, **7:15am**, **and 8:15am** CT each weekday (each, a "Contest Round"), when the Station gives the "cue-to-call" sounder, listeners must call the Station at **913-600-1011**. Caller ten (10) to the Station, as determined by the Station in its sole discretion, will win the Prize (as defined below) and will play the "Sparks and Lux Christmas Gift Match" game for a chance to win a Grand Prize (as defined below).

The caller will choose two (2) numbers between one (1) and forty (40) from the "Sparks and Lux Christmas Gift Match Game Board." If the Prize associated with each selected number matches, the listener wins that Prize, after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. If the Prizes associated with each selected number do not match, the caller does not win, and the game is over until the next cue-to-call is given during the next Contest Round.
