KENZ "WIN tickets to Laufey! **Online**" **Contest Official Rules**

No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.

Eligibility. All entries must be received by 10:00am MDT on 09/30/2025 to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address.
