KIIM-FM & K-HIT'S "DISNEYLAND RESORT SONG OF THE DAY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KIIM-FM and KHYT-FM (collectively, "Station"), 575 W Roger Road Tucson, AZ 85705, during available business hours Monday through Friday, on the Station websites www.kiimfm.com and www.khit1075.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **KiiM-FM & K-HIT's "Disneyland Song of the Day"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the last 180 days, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the **180 days.** Void where prohibited by law. Employees of Station, Cumulus Radio LLC and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein. A person may become a Qualifier (as defined below) one (1) time in this Contest.

- 2. Contest Period. The Contest entry period will begin at 6:00am MST on Friday, October 17, 2025 and will run through 7:00pm MST on Friday, November 14, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**

ON-AIR-KIIM-FM

Listen to the Station weekdays from Monday, October 20, 2025 through Friday, November 14, 2025 at or around 6:40am, 7:40am and 8:40am MST for the "Disneyland Resort Song of the Day" announcement. The Station will announce what the Disneyland Resort Song of the Day is for that day and the one (1)-hour window during which it will play later that day (before 6:00pm MST) ("KIIM Listening Window"). Listen to the Station during the KIIM Listening Window for the Station to play the Disneyland Resort Song of the Day. Immediately following when the Station plays the Disneyland Resort Song of the Day, listeners should call the Station at (520) 369-5446. Caller nine (9) to the Station, as determined by the Station in its sole discretion, will be eligible to win a Prize or the Grand Prize (each a "Qualifier"). There will be twenty (20) Qualifiers from this entry method. All entries may be played on the air.

ON-AIR-KHYT-FM

Listen to the Station weekdays from Friday, October 17, 2025 through Thursday, November 13, 2025, on or around 12:00pm and 5:00pm MST for the Disneyland Resort Song of the Day announcement. The Station will announce what the Disneyland Resort Song of the Day is and the one (1) -hour window between 6:00am and 10:00am MT during which the Station will play it in on the following weekday ("KHYT Listening Window"). Listen to the Station during the KHYT Listening Window for the Station to play the Disneyland Resort Song of the Day. Immediately upon the conclusion of the Disneyland Resort Song of the Day, listeners should call the Station at (520) 848-1075. The first caller to the Station as determined by the Station in its sole discretion, will be a Qualifier. There will be twenty (20) Qualifiers from this entry method. All entries may be played on the air.

<u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

There will be up forty (40) total Qualifiers in this Contest.

- 4. **Winner Selection.** On or about 10:00am on Monday, November 17, 2025, Station will select one (1) entry for the Grand Prize in a random drawing from among all valid Qualifiers received by Station during the Contest Period. The Qualifiers that do not win the Grand Prize will win a Prize. The Qualifiers will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days will result in disqualification. The Qualifiers that are awarded a prize are each a "Winner."
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The approximate retail value ("ARV") of each Prize is One Thousand Three Hundred Twenty Dollars (\$1,320).

Grand Prize. One (1) Grand Prize will be awarded in this Contest. The Grand Prize Winner will receive:

- Hotel accommodations for four (4) people (one (1) standard studio/quad occupancy, including room tax, subject to certain room availability) for up to two (2) consecutive nights at a Premises (as defined below) hotel or Premises-area hotel selected by Prize Provider in its sole discretion.
