92.5 KJJY'S "KITCHEN REFRESH" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KJJY ("Station"), 4143 109th Street, Urbandale, Iowa 50322, during available business hours Monday through Friday, on the Station website www.kjjy.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **92.5 KJJY's "Kitchen Refresh"** Contest (the "Contest") substantially as described in these rules and by participating, each entrant agrees as follows:

1. No purchase is necessary to enter or win. A purchase will not increase your chance of winning. Void where prohibited. All federal, state, and local regulations apply.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who, as of October 19, 2025, own a residence and have the right to make renovations to the residence, and who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days. Void where prohibited by law. Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and stepparents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

- 2. Contest Period. The Contest entry period will begin at 12:00 AM CT on October 20, 2025 and will run through 11:59 PM CT on November 7, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There is one way to enter this Contest:

Online: Visit the Station's website at www.kjjy.com during the Contest Period, click on the "Contest" link, click on the "Kitchen Refresh" Contest link, and complete and submit an entry form. All entries must be received by 11:59 PM CT on November 7, 2025 to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the right to

contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries or emailed entries will be accepted.

4. Winner Selection.

- A. Qualifiers: On or about 12:00 PM CT each weekday from October 21, 2025 through November 10, 2025, Station will select, in a random drawing, three (3) potential winners each Monday from among all eligible entries received through 11:59 PM CT the immediately previous Sunday and one (1) potential winner each Tuesday, Wednesday, Thursday, and Friday from among all eligible entries received through 11:59 PM CT the immediately previous weekday (each such potential winner, a "Qualifier"). LIMIT ONE QUALIFIER PRIZE PER ENTRANT.
- B. Grand Prize Winner: On or about 12:00 PM CT on November 10, 2025, Station will select one (1) potential grand prize winner in a random drawing from among all Qualifiers.
- C. The Qualifiers and the grand prize winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
- Verification of Potential Winners. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5. IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. - A. Qualifier Prizes. Nineteen (19) Qualifier prizes will be awarded (one for each day of the Contest Period). Each Qualifier will receive: One (1) \$25 Sweet Deals gift certificate. Approximate retail value ("ARV") of each Qualifier prize is \$25.
- B. Grand Prize: One grand prize will be awarded to one Qualifier. In addition to the Qualifier prize above, one grand prize winner will receive: One (1) residential kitchen renovation/upgrade from Kitchen Refresh, valued up to \$9,250 (subject to scheduling and other restrictions as determined by Kitchen Refresh). ARV of the grand prize is up to \$9,250.

ARV of all Contest prizes is: up to Nine Thousand Seven Hundred Twenty-Five Dollars (US\$9,725).
