## 103.3 COUNTRY & 93.3 THE BULL'S "ZAMBONI SONG FRIDAY – PREDATORS V. JETS 11/29" TEXT CONTEST OFFICIAL RULES

The Stations will conduct the 103.3 Country & 93.3 The Bull's "Zamboni Song Friday – Predators v. Jets 11/29" Text Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Nashville, TN or Salt Lake City, UT Designated Market Area ("DMA"), as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last seven (7) days, or a prize valued at \$500 or more in the last seven (7) days, and whose immediate family members or household members have not won a prize from the Station in the last 7 days, or a prize valued at \$500 or more in the last 7 days. The term "household members" refers to people who share the same residence at least three (3) months out of the year. - 3. How to Enter and Win. Listen to the "Jesse James Morning Show" ("Show") airing simultaneously on Stations weekdays during the Contest Period. When the Station plays the "cue-to-call" Zamboni Song sounder, listeners must send a text message with the keyword "SMASHVILLE" to 615-737-1033 during the Contest Period. All entries must be received by 8:00am CT on November 28, 2025, to be eligible for the Prize drawing. Standard text messaging rates, as established by an individual's wireless carrier, may apply, and Station assumes no responsibility for any fees or charges incurred for and associated with any text message sent to or from Station. Any and all fees arising out of the transmission of a text message shall be the sole responsibility of the entrant. Limit one (1) entry per person per phone number. Multiple participants are not permitted to share the same telephone number. Any attempt by any participant to submit

more than one (1) entry by using multiple/different telephone phone numbers, identities, or any other methods will void that participant from further participation in the Sweepstakes.

- 4. **Text Winner Selection.** At or around 9:00am on November 28, 2025, Station will select a minimum of one (1) entry for the Prize in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within one (1) hour of notification will result in disqualification and forfeiture of the prize.
- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize.
