KYKZ-FM'S "SMOKE & BARREL BOURBON, BBQ & WHISKEY" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station **KYKZ-FM** ("Station"), 425 Broad Street, Lake Charles, LA 70601, during available business hours Monday through Friday, on the Station website www.kykz.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the KYKZ-FM "SMOKE & BARREL BOURBON, BBQ & WHISKEY Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59 pm CT on August 10, 2025, to be eligible for a chance to win a prize. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Station reserves the right to

Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.
