

96.1 JAMZ'S "UNIVERSAL ORLANDO RESORT HOLIDAYS" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WHBX ("Station"), 3411 West Tharpe St Tallahassee FL 32303, during available business hours Monday through Friday, on the Station website www.961jamz.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **96.1 Jamz's "Universal Orlando Resort Holidays"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the last **60 days**, and whose immediate family members or household members have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the last **60 days. Void where prohibited by law.** Employees of Station, **Cumulus Broadcasting LLC**, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will begin at **12:00AM ET on Monday, November 17, 2025** and will run through **11:59PM ET on Tuesday, December 16, 2025** (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

3. **How to Enter.** There is one way to enter this Contest.

Online: Visit the Station's website at www.961jamz.com during the Contest Period, click on the "Contest" link, click on the "96.1 Jamz wants to send you to Universal Orlando Resort" Contest link, and complete an entry form. All entries must be received by 11:59PM ET on December 16, 2025 to be eligible for a chance to win a prize. **Limit one (1) entry per person, regardless of how many email addresses a person may possess and use.** Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the

right to contact entrants and all other individuals whose email address is submitted as part of this Contest. No mail-in entries will be accepted.

4. **Winner Selections**

A. **Qualifiers.** On or about 10:00AM ET each Monday, Tuesday, and Wednesday starting on Monday, November 24, 2025 and continuing through Wednesday, December 17, 2025 (each, a “Selection Day”), Station will select one (1) qualifier from among all eligible entries received through 11:59PM ET the night immediately prior to each Selection Day (each, a “Qualifier”). Each Qualifier will win a Qualifier prize. **Limit one Qualifier prize per person.**

B. On or around 10:00AM ET on Friday December 19, 2025, Station will select one (1) grand prize winner in a random drawing among all Qualifiers.

C. Each Qualifier will be contacted using the email address and/or telephone number provided with the entry and may be awarded the Qualifier prize (and, if applicable, the grand prize) (subject to verification of eligibility and compliance with the terms of these rules).

D. Station’s decisions as to the administration and operation of the Contest and the selection of the potential winners are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. Each potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. Each potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. Each potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the Contest prize(s) and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period, or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. If a potential winner of a prize is disqualified for any reason, Station may award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Unclaimed prizes may not be awarded.

A. **Qualifier Prizes.** Twelve (12) Qualifier prizes (one for each Selection Day) will be awarded in this Contest. Each Qualifier will receive: Two (2) 2-Park 1-Day Park-to-Park + 1-Day Regular Parking tickets for admission to Universal Studios Florida and Universal Islands of Adventure.

Approximate Retail Value (“ARV”) of each Qualifier prize: \$468.00

B. **Grand Prize.** One grand prize (for one Qualifier) will be awarded in this Contest. In addition to the Qualifier prize described above, the grand prize winner will receive:

- (i) Two (2) nights standard hotel accommodation (one room, quadruple occupancy, for grand prize winner and up to three guests, room and tax only) at Universal's Cabana Bay Beach Resort or at another Universal Orlando Resort Hotel (as determined by Universal Orlando and/or Station in their sole discretion);
- (ii) Two (2) nights of overnight self-parking at a Universal Orlando Resort Hotel (valid for one (1) vehicle);
- (iii) Four (4) Universal Orlando 3-Park 3-Day Park-to-Park tickets for admission to Universal Studios Florida and Universal Islands of Adventure theme parks, and Universal Volcano Bay water theme park for grand prize winner and up to three (3) guests.

ARV of the grand prize: \$2,463.62

C. Travel dates and arrangements are subject to blackout dates between December 26, 2025, and December 31, 2025. Other prize and travel restrictions may apply. All elements of the prize must be redeemed at the same time, and no changes will be permitted after confirmation of any redemption. Travel dates are subject to Universal Orlando and Station approval. Reservations are subject to availability. **Trip must be booked at least seven (7) days prior to intended departure date.** If grand prize winner elects to partake in any or all portions of the Grand Prize with fewer than the allotted amount of guests or no guests, the Grand Prize will be awarded to grand prize winner and each participating guest and any remainder of the grand prize will be forfeited and shall not be subject to any compensation. . Grand prize winner must be eighteen (18) years of age or older. **If the grand prize winner is between the ages of eighteen (18) and twenty-one (21) years of age, he/she must be accompanied by an adult, who is at least twenty-one (21) years of age in order to check into the hotel.** Minor guests, if any, must be accompanied by a parent or legal guardian. Prizes are non-transferable and have no cash value. Any difference between stated ARV and final ARV of prize will not be awarded. Unless otherwise indicated, all tickets specifically exclude admission to special or separately ticketed "hard ticket" entertainment events at any of the theme parks, hotels, or within any of the Universal CityWalk venues such as Hard Rock Live®.

D. All parts of the prize selected are subject to availability and blackout dates, and subject to change without written notice or warning. Should an act of God, hurricane, war, fire, riot, earthquake, act of public enemies, actions of governmental authorities, epidemics, pandemics and the spread of infectious diseases, and any related governmental or judicial actions taken in connection with, or as a response to, any such event, or any other event beyond the reasonable control of a party, whether or not existing, known, foreseen or foreseeable at the time this Contest occurs, render the redemption or fulfillment of some or all of the prize delayed, hindered, adversely affected, impracticable, or impossible, Universal in its sole and absolute discretion, reserves the right to evaluate and make modifications to the redemption and fulfillment processes and timelines for any prize or portion of the prize that Universal Orlando is responsible for, which may include but is not limited to providing additional time for redemption and/ or fulfillment. Should the prize become unavailable, experiences and items of a similar nature and value may be offered.

Station reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or acting in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Station reserves the right to seek damages from any such person to the fullest extent permitted by law. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
11. **Limitations of Liability.** The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by Station, Sponsor, entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error that may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use, non-use or misuse of any prize. In event that a production, technical, programming or other error causes more than stated number of prizes as set forth in these Official Rules to be claimed, Station reserves the right to award only the stated number of prizes by a random drawing among all legitimate, unawarded, eligible prize claims.
12. **Disputes.** Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate state court located in the Station's listening area; (c) any and all claims,

judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and Station in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the state in which the Station is located, without giving effect to any choice of law or conflict of law rules (whether of the state in which the Station is located or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state in which the Station is located.

Station is not responsible for any incorrect or inaccurate information entered by website users, and assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to Station's website.
