## "SUPPORT LOCAL, WIN LOCAL" CONTEST

## **Official Rules**

A complete copy of these rules can be obtained at the offices of radio stations WKSM, WNCV, WYZB and/or WZNS ("Stations"), 225 NW Hollywood Boulevard, Fort Walton Beach, FL, during available business hours Monday through Friday, on the Stations' websites (WKSM: <a href="www.WKSM.com">www.WKSM.com</a>), (WNCV: <a href="www.WNCV.com">www.WKSM.com</a>), (WYZB: <a href="www.y1055country.com">www.y1055country.com</a>) or (WZNS: <a href="www.Z96.com">www.Z96.com</a>), or by sending a self-addressed, stamped envelope to the above address.

The Stations will conduct the "SUPPORT LOCAL, WIN LOCAL" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. All entries must be received by 11:59 p.m. CT on Sunday, November 30, 2025, to be eligible for a chance to win a prize. Limit one (1) entry per person per email address. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry and the entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Stations are not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. - 4. **Winner Selection.** On or about 10:15 a.m. CT on Monday, December 1, 2025, Stations will select one (1) prize winner in a random drawing from among all valid entries received via all Station websites through the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with their entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Stations have the right (without obligation) to announce on the air winner's name, city of residence, or any other part of the entrant's Contest entry. Stations' decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within twenty-four (24) hours of notification will result in disqualification.
