WKXS "HAWK TAILGATER COOLER 2025 PHASE THREE" CONTEST OFFICIAL RULES

The Station will conduct the WKXS "Hawk Tailgater Cooler 2025 Phase Three" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING, VOID WHERE PROHIBITED, ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. Limit one (1) entry per person per day, regardless of how many email addresses a person may possess and use. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to submit more than one (1) entry per day by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entry, and the entrant may be disqualified.
