# KISS'S "3<sup>RD</sup> ANNUAL CAPITAL CITY BLUES FESTIVAL" CONTEST OFFICIAL RULES

The Station will conduct the **KISS'S 3<sup>RD</sup> ANNUAL CAPITAL CITY BLUES FESTIVAL**" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, , age eighteen (18) or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the 30 days Void where prohibited by law. Employees of Station, CUMULUS RADIO, LLC/ KISS 103.1 and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Contest Period. The Contest entry period will begin at 6AM EST on 2 October 2025 and will run through 2 PM on Friday 31 October 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

- 2. How to Enter. A total of 30 pairs of tickets to be given away. One winner will be drawn from the text to win list on the Winning Weekend, 3 October -5 October, Caller #13 and week of 6 October-10 October, Name That Tune Challenge week of 13 October -17, Play That Tune week of October 20-October 24, Winning Weekend Oct 25-26, and Count Down October 27-31 no later than 3 PM. On Air Giveaway, Caller #10.
- On-Air: Listen to the Station weekdays during the Contest Period. When the Station plays the "cueto-call" sounder, listeners must call the Station at (803) 695-5477. Caller number 10 to the Station, as determined by the Station in its sole discretion, will be entered for a chance to win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.

4. Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by KISS 103.1/WLXC will be deemed not entered in the Contest.

All entries must be received by 7 PM on 30 October, 2025 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number

- 5. Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.
