

B106.7's "SOUTHERN SHORES DENTAL"

CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station B106.7 ("Station"), 1301 Gervais Street, Suite 1950 Columbia, SC 29204, during available business hours Monday through Friday, on the Station website www.b106.7fm.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **B106.7's "SOUTHERN SHORES DENTAL"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.**

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, , age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last **30 days** or a prize valued at \$500 or more in the **30 days, Void where prohibited by law.** Employees of Station, B106.7 and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. The term "immediate family members" includes spouses, parents and step-parents, siblings and step-siblings, and children and stepchildren. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Station's decisions, which are final and binding in all matters related to the Contest. Winning a prize is contingent upon fulfilling all requirements set forth herein.

2. **Contest Period.** The Contest entry period will begin at 10 AM on Saturday, 27 September 2025, and will end by 11:59 Midnight on Sunday, 28 September 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest. All winners will be selected no later than Monday, 29 September 2025 by 5 PM.

- (1) Visit the Station's B1067 FB page during the Contest Period;
- (2) Winners must follow the instructions on Facebook and/or Instagram to go in the running to win.
- (3) Must like B106.7 on Facebook and/or Instagram
- (4) Must share the post
- (5) Must tag three friends who make you smile in the comments.

4. **IN ALL MATTERS RELATED TO THE CONTEST.** The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days) of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return

the prize. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
