"SUPPORT LOCAL, WIN LOCAL" CONTEST

Official Rules

A complete copy of these rules can be obtained at the offices of radio stations WKSM, WNCV, WYZB and/or WZNS ("Stations"), 225 NW Hollywood Boulevard, Fort Walton Beach, FL, during available business hours Monday through Friday, on the Stations' websites (WKSM: www.WKSM.com), (WNCV: www.WKSM.com), (WYZB: www.y1055country.com) or (WZNS: www.Z96.com), or by sending a self-addressed, stamped envelope to the above address.

The Stations will conduct the "SUPPORT LOCAL, WIN LOCAL" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
