



# CRACK THE CODE RULES AND REGULATIONS

Monday, October 7, 2024

1. **The Q!'s Crack the Code** game/contest, hereinafter known as “the contest” is open to all British Columbia residents 19 years of age or older.
2. Active and retired employees and their immediate families (including but not limited to ‘significant others,’ siblings, parents, children and any persons belonging to the household of the above persons) of Pattison Media Ltd., 100.3 The Q!, their affiliates, any participating sponsors, their affiliated corporations, agencies or agents are not eligible to enter/win the contest.
3. There is no purchase necessary to enter the contest.
4. Only ONE member of a household will be eligible to qualify or win in any single Contest.
5. The contest is subject to all applicable federal, provincial and municipal laws and regulations.
6. **To enter the contest:** Listen to 100.3 The Q! Upon hearing the cue-to-text and texting the word “CODE” one texter will be randomly drawn to play “Crack the Code” from all text messages that are entered during the time allotted by the announcer executing the contest play. There will be a minimum of three chances daily to play “Crack the Code” Monday to Friday (excluding statutory holidays), between 6:00 AM and 6:00 PM Pacific Time Monday, October 7, 2024, to Friday, October 25, 2024.
7. **Grand Prize Details:** A maximum of 45 different contestant(s) will be given the opportunity to match exactly a predetermined four (4) digit number combination which has been pre-programmed into the “Crack the Code” website provided by IP Group. The \$500,000.00 grand prize will be awarded to the first contestant who matches exactly the predetermined winning combination which is on file at IP Group during a contesting occasion. **There may be no more than 45 total guess(es), which are eligible for this contest under any circumstance.** There shall be a maximum of one (1) winner.
8. **Secondary Prize details:** A winner will be drawn from all contestant (s) who played “Crack the Code” between Monday October 7 and Friday October 25, 2024. The \$1,000.00 (one-thousand dollars) in BCLC lottery tickets secondary prize will be awarded to a contestant who is randomly drawn and announced by/on The Q Morning Show, Monday October 28, 2024. There shall be a maximum of one (1) winner.
9. Drawn contestants may only play “Crack the Code” once between Monday October 7, 2024, 6:00AM PT and Friday October 25, 2024, midnight PT during contest play window as determined by on-air announcer executing the contest.
10. The opportunity to win begins at **6:00AM PT on Monday, October 7<sup>th</sup>, 2024.**
11. The odds of winning the Grand Prize are 10,000: 1
12. The odds of winning the Secondary Prize are 45: 1
