

The Vancouver Island Starter Pack RULES AND REGULATIONS

Monday, April 28, 2025

- 1. **The Vancouver Island Starter Pack** game/contest, hereinafter known as "the contest" is open to all British Columbia residents 19 years of age or older.
- 2.
