- The Station reserves the right to **substitute a prize** of equal or greater value if the original prize becomes unavailable.
- Complimentary event tickets have a resell value of \$0.00 and are prohibited from resale without violating WI ticket scalping laws. Any persons found to be scalping tickets may be reported to the authorities and/or their complimentary tickets voided by the event organizers.
- The “winner” is identified as the individual to whom the judge is awarding the prize and **MUST** be the owner/renter of the entry method used to win the prize. e.g. phone number, email address, IP address and **MUST** have valid personal identification. An individual cannot enter on behalf of another person or give another person’s identification information at the time of a potential win.

5. PRIZE CONDITIONS

10. GOVERNING LAW & DISPUTES

- These rules are governed by **Michigan state law and U.S. federal law**.
- Any disputes or claims must be resolved in the courts of **Michigan**, and entrants waive the right to class-action litigation.

11. STATION RIGHTS

- The Station reserves the right to **cancel, suspend, or modify any contest** for any reason, including fraud, technical issues, or unforeseen circumstances.
- The Station's **decisions regarding contest eligibility, prize distribution, and rule interpretation are final**.
