1. The benchmark contests run Monday, July 14th thru Friday, August 1st
2. The Jim Davis Show on The TEAM will air the Debut Debate, brought to you by Triple Play Records.
3. Contests are open to anyone 18 years of age and older, unless otherwise specified
4. Each morning, one listener will qualify each hour with a rock album assigned to them randomly.
5. The albums have already been selected by The Jim Davis Show crew and Triple Play owner Rock Cesario.
6. 12 listeners will compete to win all 12 albums along with an Audio Technica belt drive turntable and a pair of Edifier speakers. Total amount: \$500.00 There will be no album substitutions.
7. The Debut Debate will be a bracket style contest with listeners voting for albums each day. Listeners will be able to vote on-line at theteam1340.com and by texting The Jim Davis Show at 970-242-1340.
8. All winners will have two-weeks to claim their prize. No prize will be awarded after the two-week window has expired. The two-week window begins from the date the prize was awarded.
9. No purchase necessary.
10. All prizes awarded "as is". Prizes are non-transferable and cannot be exchanged. No cash value.
11. All contests are open to the general public, except for: employees, agents, subsidiaries and affiliates of MBC Grand Broadcasting, Inc., participating sponsors, their immediate families and household members.
