

## **RULES AND REGULATIONS**

### **K-97 Get the F1 Outta Here**

The K-97 Get the F1 Outta Here is an on-air call-in-to-win contest being conducted by CIRK-FM (K97) in Edmonton, a station owned and operated by Stingray Radio Inc., (the "Contest Organizer") from Monday, January 8, 2024 to Friday, February 9, 2024 excluding statutory holidays (the "Contest period"). The contest will play a minimum of 75 times during the Contest period. Each contest play has a potential qualifier prize of a 4pack of tickets to the February 10, 2024 Rad Torque Raceway Speedway Market and entry into the Monday, February 12, 2024 Grand Prize Draw

No purchase necessary, but contest applicants must be registered K-97 Army Members. In order for the chance to play the Get the F1 Outta Here contest, a person (contest applicant) must enter via the Get the F1 Outta Here Contest page on K97.ca; active between Tuesday, January 2, 2024 and Friday, February 9, 2024. The person (the contest applicant) completing the on-line entry form must completely fill-out all contest fields.

For the chance to qualify the K-97 Get the F1 Outta Here, listen to K-97 FM weekdays at approximately 8:00am MST, 12:00pm MST, & 4:00pm MST. During these contest times, K-97 will randomly select a Get the F1 Outta Here qualifier name that entries submitted via the on-line K-97 Army Get the F1 Outta Here contest entry form. The Get the F1 Outta Here qualifier name that is announced will have 9-minutes and 7-seconds to call-in to 780-451-8097 to claim their qualifier prize and entry in the Monday, February 9, 2024 Grand Prize Draw. In the event that the selected Get the F1 Outta Here qualifier does not call-in within the 9-minute and 7-second time allotment, another name WILL NOT be drawn for that contest play.

In the event a Get the F1 Outta Here qualifier misses their name being called, the qualifier's entry will put back into the entry system for upcoming Get the F1 Outta Here qualifier draws.

The Contest is open to all legal residents of Edmonton Radio Survey Area as defined by Numeris who are eighteen (18) years of age or older with a valid Alberta Driver's License and/or Alberta Passport, excluding employees of K-97, Stingray Radio, its parent company, affiliated companies, advertising and promotional agencies, local radio stations; their staff and personalities, participating sponsors and any persons residing in their respective households. This Promotion is subject to all applicable federal, provincial, and local laws and regulations.

#### **Limit of winning qualifier spot per person, per household.**

In order to claim their qualifier prize and be entered for the Grand Prize Draw, the selected entrant must first complete, and return, the K-97 Get the F1 Outta Here waiver form, with the mathematical skill testing question to Stingray Radio Edmonton Inc. ### **GENERAL CONDITIONS**

**Verification.** Online entries, if applicable, are subject to verification by the Contest Organizers. Any entry which is incomplete, incomprehensible, inaudible, illegible, fraudulent, mutilated, altered, contains false information or is not received within the Contest Period, or otherwise does not conform to these Contest Rules will automatically be rendered invalid and will not entitle such entrant to be eligible for a prize.

**Disqualification.** The Contest Organizers reserve the right to disqualify any person or cancel the entry of any person participating in this Contest or trying to participate by means contrary to these Contest Rules or in a manner which is unfair to other entrants as determined by the Contest Organizers in their sole and absolute discretion (e.g.: use of an Entry Form obtained from an unauthorized source, entries exceeding the limit allowed, computer hacking, etc.). Any attempt to tamper with the entry process, interfere with these Contest Rules, deliberately damage any website or undermine the administration, security or legitimate operation of the Contest, is a violation of criminal and civil laws and the Contest Organizers reserve the right to seek damages and/or

other relief from all persons responsible for such acts to the fullest extent permitted by law, which may include banning or disqualifying entrants from this and future contests. Such person may be referred to the appropriate judicial authorities.

**Noncompliance/eligibility.** If a potential or declared winner is not in compliance with these Contest Rules, as determined by the Contest Organizers in their sole and absolute discretion, the Contest Organizers reserve the right to disqualify such entrant from the Contest and randomly select further entrants from the remaining eligible entries until a winner is finally declared. Any potential or declared winner, who is not in compliance with these Contest Rules, must so inform the Contest Organizers immediately upon being contacted by the Contest Organizers.

**Substitution of prize.** In the event it is impossible, difficult and/or costlier for the Contest Organizers to award a prize (or part of a prize) as described in these Contest Rules, the Contest Organizers reserve the right to award a prize (or part of a prize) of similar nature and equivalent value or, at their sole discretion, the value of the prize (or of the part of the prize) in cash.

**Modification.** The Contest Organizers reserve the right, at their sole discretion, to cancel, terminate, modify or suspend this contest, in whole or in part, in the case of the occurrence of an event, an error or any human intervention that could corrupt or affect the administration, safety, impartiality or the running of the Contest as provided in these Contest Rules.

**Limit of prizes.** In no event shall the Beneficiaries be obligated to award more prizes than set out in these Contest Rules or to award prizes otherwise than in compliance with these Contest Rules.

**Impossibility to act – labour dispute.** The Beneficiaries shall not be responsible for any damages for a failure to operate the Contest in accordance with these Contest Rules in any case where their incapacity to act results from circumstances or a situation beyond their reasonable control or because of a strike, lock-out or any other labour dispute in their company or those of businesses which services are used for holding this Contest, war, riot, insurrection, earthquake, terrorism, civil commotion, fire, flood, accident, storm or any other act of nature.

**Liability limit– participation.** Any person who participates or tries to participate in this Contest releases the Beneficiaries from any and all liability for damages which he/she could suffer from participating or trying to participate in this Contest.

**Authorization.** By entering this Contest, each declared winner consents to the Contest Organizers, and their representatives, to use, at their sole discretion and if required, their name, photograph, image, likeness, testimonial related to the prize, place of residence and/or voice without compensation whatsoever and that, without limit as for the period of use, in any media and on a worldwide scale, for publicity purposes or for any purpose that may be considered relevant. A declaration to such effect will be included in the Release Form.

**Property of entries.** Entry Forms are the sole property of the Contest Organizers and at no time will be returned to entrants.

**Personal information.** By participating in the Contest, Participants consent that any personal information that is submitted as part of the Contest be stored, shared and used by the Contest Organizers, their representatives, media partners, advertising and promotional agencies, solely for the purpose of administering the Contest and in accordance with the Contest Organizer's privacy policy publicly available on the Contest Organizer's website. There will be no communication of commercial or of any other

nature, unrelated to this Contest sent to an entrant, unless such entrant gives specific authorization to the Contest Organizers for that specific purpose.

**Decisions of the Contest Organizers.** All decisions of the Contest Organizers or those of their representatives regarding this Contest are final and binding on all entrants with no rights to appeal.

**Identification of the contestant.** For the purposes of these Contest Rules, the entrant is the person whose personal information is printed on the Entry Form. It is to this person that the mathematical skill-testing question will be asked and the prize awarded if selected and declared a winner.

**Unenforceability.** If a section of these Contest Rules is declared or ruled by a Court of Law as illegal, unenforceable or void, that section will be deemed void but all other sections not affected will be enforced as allowed by Law.

**Jurisdiction.** This Contest is subject to all applicable federal, provincial and municipal laws.
