

## **Rules & Regulations**

### **96.3 The Breeze Backyard Wine Down**

No purchase necessary. The Contest is open to all residents of Edmonton and area, eighteen (18) years of age or older, excluding residents of Quebec, employees of 96.3 THE BREEZE, Stingray Radio, its parent company, affiliated companies, advertising and promotional agencies, participating sponsors and any persons residing in their respective households.
