

## **Official Contest Rules & Regulations**

### **CIHT-FM OTTAWA | THE NEW HOT 89.9**

#### **OMG I WANT THAT (the 'Contest')**

1. Dates/Terms/Eligibility. CIHT-FM (The New HOT 89.9) – Stingray. (the "Station") has set an expiry date of Friday, March 26<sup>th</sup>, 2021 for OMG I WANT THAT (the "Contest"), however it reserves the right to terminate or extend the contest at any time. Any material changes will be broadcast on the Station and posted on its official website ([www.HOT899.com](http://www.HOT899.com)), within the Contest section. The Contest is open to legal Canadian Residents and students 18 years of age or older, residing in the province of Ontario. There is no purchase necessary to participate or to win. Employees or agents of the Station, all other Stingray stations in Canada, or any entity associated with the Contest, as well as members of the same household of any such employee or agent may not participate.

2. How To Enter. NO PURCHASE NECESSARY. Beginning Monday, February 1, 2021 we'll encourage listeners to be listening for the codeword every hour on Hot 89.9 to enter. Text the code word to 613-750-8990 and the on air personality could be calling you within that hour. Ex. You hear the codeword at 1:00pm, HOT 89.9 has until 1:59pm to call the qualifier. How it will work, every Monday morning, the Morning Hot Tub with Mauler, Rush and Jenni will announce the OMG I WANT THAT! prize for the week. The latest, greatest, most decadent or hard to get prizes and experiences you can imagine are up for grabs. Each and every weekday (Monday to Friday) between 9am to 5pm The New Hot 89.9 will qualify one lucky listener every hour for the chance to win the prize that was announced for that week.

There will be a different prize every week for the 8 weeks of the contest. Listeners can only qualify once for each prize. If you qualify for one prize and don't win it, you can qualify again for another one.

\*Due to unknown future of COVID 19 and the measures that will be in place during the timeline of this contest, the winner of each week will have the choice of having the item delivered directly to their home or they can receive the cash value of the prize.

The following Monday, The Morning Hot Tub with Mauler, Rush and Jenni, will announce the previous week's winner and announce the next OMG I Want THAT! prize to be won. This will continue for the full 8 weeks.

Grand Prizes are non-transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability. In which case, a prize of equal or greater value will be awarded. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the Prize.

3. Prizes. There is one (8) Grand Prize to be won. The value of the Grand Prize is pre-determined by Station management and will be kept secret from all participants. The odds of winning a Grand Prize will depend on the number of listeners who enter online for the contest.

10 WEEK EXECUTION – FEB 1 – MAR 26. A Prize will be given out every Monday for the 8 weeks starting on Monday, February 1<sup>st</sup> with the Morning Hot Tub with Mauler, Rush and Jenni.

4. Conditions/Restrictions. In order to be declared a 'Winner', the selected participant(s) will be required to correctly answer, unaided, a time-limited, mathematical skill-testing question, to be administered by the Station. Each winner will be required to produce identification satisfactory to the Station. They will also be required to sign an affidavit of eligibility and release, including a publicity release as prepared by the Station prior to receiving their Prize.

5. Conditions/Restrictions. The Station is not responsible for errors, problems or delays in the mail, telephone or on-line web systems that may prevent listeners from participating In the Contest. Participants can call the Station main line (613-723-8990) if they have any questions in relation to the Contest. Decisions of the Station judges are final.

6. Release and Indemnification. In exchange for the right to participate in the Contest, each participant agrees to release and indemnify the Station, Stingray and its officers, directors, agents, parent companies, subsidiaries and employees (the "Released Parties"), from any and all claims, demands and/or causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the participant's participation in the Contest.

7. Rules. This contest is subject to all applicable federal, provincial and municipal laws. By entering, each participant agrees to abide by these rules and regulations and the decisions of the Station judges which are final with respect to all aspects of the contest. Any violation of these rules will result in disqualification. Copies of these
