

Official Contest Rules & Regulations
CIHT-FM OTTAWA | THE NEW HOT 89.9
The \$10,000 Secret Celebrity Contest Timer (the 'Contest')

1. Dates/Terms/Eligibility. CIHT-FM (The New HOT 89.9) – Stingray. (the "Station") has set an expiry date of Friday, February 28th 2025 for The \$10,000 Secret Celebrity Contest (the "Contest"), however it reserves the right to terminate or extend the contest at any time. Any material changes will be broadcast on the Station and posted on its official website (www.HOT899.com), within the Contest section. The Contest is open to legal Canadian Residents and students 18 years of age or older, residing in the terrestrial broadcast range of the Station. There is no purchase necessary to participate or to win. Employees or agents of the Station, all other Stingray stations in Canada, or any entity associated with the Contest, as well as members of the same household of any such employee or agent may not participate.

2. How To Enter. NO PURCHASE NECESSARY. Beginning Monday January 27th 2025 the Morning Hot Tub with Mauler, Rush, Jenni and Brady will announce the Contest. The Station will encourage listeners to listen weekdays beginning February 3rd, 2025 at 9am, 12pm, and 4pm. At those times the announcer will say a keyword. Listeners must text that keyword to 613-750-8990. The announcer will call one texter (the "contestant") and them to identify the 10 celebrity voices speaking the phrase "The New HOT 89.9 Ten Thousand Dollar Secret Celebrity Contest." There is a different celebrity voice for each word. For the purposes of this contest, "89.9" is one word. If the contestant can successfully identify all of voices in order they will win \$10,000! There is no limit to how many times a listener can try to become a contestant (ex. if a Contestant talks to an announcer and submits their guess at 9am, they may try to enter the contest later that day at 12pm).

All of the voices used are public figures. If the person is known under a stage name, ex. Madonna, the stage name will qualify as a correct answer. If a celebrity has an honourific in their name, ex. Sir Benjamin Kingsley, it will not be required to say the honourific. Saying a shortened version of a celebrity name, ex. Tom Hanks instead of Thomas Hanks, will be accepted as a correct answer. Nicknames, ex. T-Hanks, will not be accepted.

3. Prizes. There is one (1) Grand Prize of \$10,000 to be given to the winner in the form of a cheque.

Prize is non-transferable or exchangeable and may not be substituted. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the Prize.

4. Conditions/Restrictions. In order to be declared a 'Winner', the selected participant(s) will be required to correctly answer, unaided, a time-limited, mathematical skill-testing question, to be administered by the Station. Each winner will be required to produce identification satisfactory to the Station. They will also be required to sign an affidavit of eligibility and release, including

a publicity release as prepared by the Station prior to receiving their Prize.

The Station is not responsible for errors, problems or delays in the mail, telephone, texting platform or on-line web systems that may prevent listeners from participating in the Contest. Participants can call the Station main line (613-723-8990) if they have any questions in relation to the Contest. Decisions of the Station judges are final.

5. Release and Indemnification. In exchange for the right to participate in the Contest, each participant agrees to release and indemnify the Station, Stingray and its officers, directors, agents, parent companies, subsidiaries and employees (the "Released Parties"), from any and all claims, demands and/or causes of action of any nature or kind whatsoever, whether presently known or unknown, foreseen or unforeseen, that arise out of the participant's participation in the Contest.

6. Rules. This contest is subject to all applicable federal, provincial and municipal laws. By entering, each participant agrees to abide by these rules and regulations and the decisions of the Station judges which are final with respect to all aspects of the contest. Any violation of these rules will result in disqualification.
